**Barbados** in the 'Americas' region



## Overview

- A total of 10 childhood vaccines are tracked for Barbados; of these, 3 reached the 90% coverage target or higher in 2025.
- Coverage of the first dose of diphtheria-tetanus-pertussis-containing vaccine (DTP1) declined from 94% in 2024 to 91% in 2025, coverage of the third dose of DTP-containing vaccine (DTP3) was the same in 2025 as it was in 2024 (85%), and coverage of the first dose of the measles-containing vaccine (MCV1) increased from 88% in 2024 to 89% in 2025 in 2025.
- In 2025, the number of zero-dose children for DTP in Barbados (<500) was approximately 50% higher than the annual number proposed to achieve the IA2030 target of halving zero-dose children for DTP by 2030 (<200), based on a linear trajectory of decline.

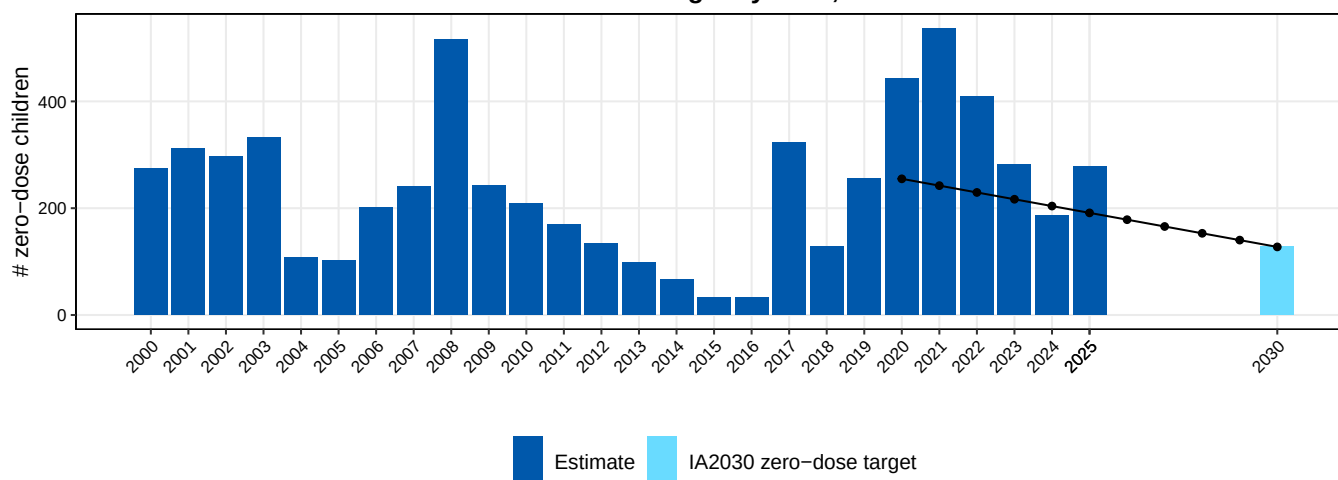

**Estimated number of zero-dose children, 2000–2025 and target by 2030, Barbados**

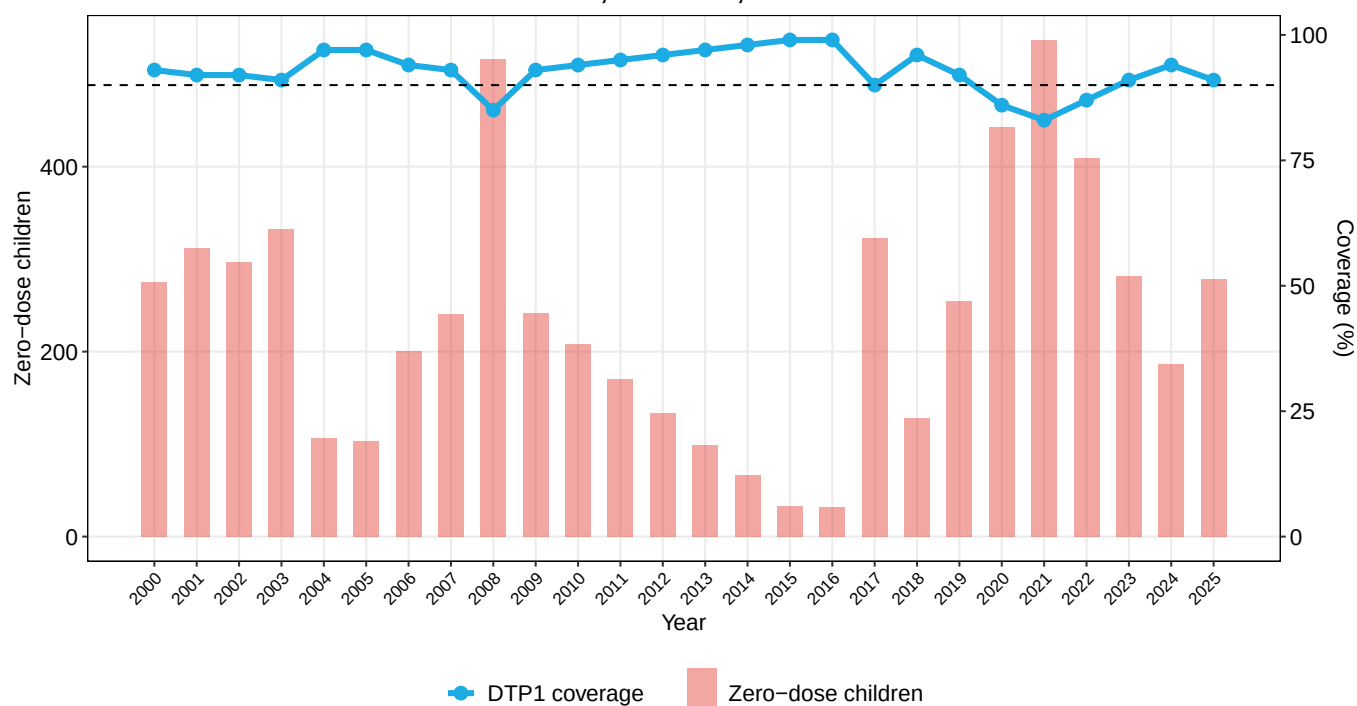

 The line and points show the yearly progress and trajectory to meet the target by 2030, based on a linear decline.

## DTP1: Reaching zero-dose children

- Coverage of DTP1 stood at 91% in 2025. This is lower than in 2019 (92%) and lower than in 2024 (94%).
- The percentage of zero-dose children was 50 percentage points higher than the IA2030 target in 2025. There were approximately <500 zero-dose children in 2025, more than the <500 in 2019 and more than the <200 in 2024.
- Coverage of DTP1 in Barbados (91%) was higher than the Latin America and the Caribbean regional average of 89% in 2025.
- DTP1-to-DTP3 dropout in 2025 was 7%, 5 percentage points higher than in 2019 (2%). Medium DTP dropout rates imply moderate ability to provide a complete vaccine series early in life.

**DTP1 coverage and zero-dose children over time, Barbados, 2000–2025**

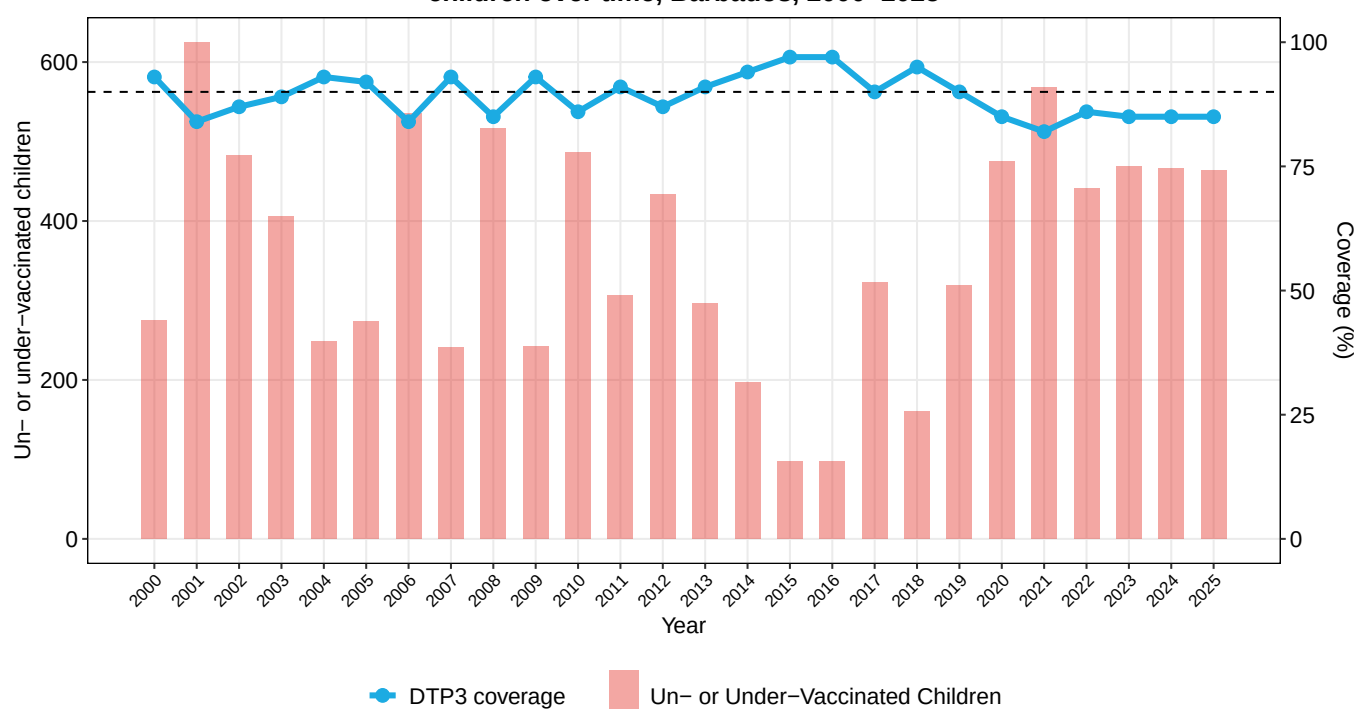


Dotted line shows the IA2030 target of 90% coverage

## DTP3: A marker of routine immunization service delivery to children

- Coverage of DTP3 stood at 85% in 2025. This is lower than in 2019 (90%) and the same as in 2024 (85%).
- The number of children vaccinated with DTP3 decreased from 3,000 in 2019 to 3,000 in 2025.
- In 2025, there were <500 children un- or under-vaccinated in Barbados.
- In 2025, 7% of children who received DTP1 did not receive DTP3. This 7% dropout rate was 5 percentage points higher than in 2019 (2%) but 3 percentage points lower than the 2024 dropout rate (10%).
- Coverage of DTP3 in Barbados (85%) was higher than the Latin America and the Caribbean regional average of 83% in 2025.

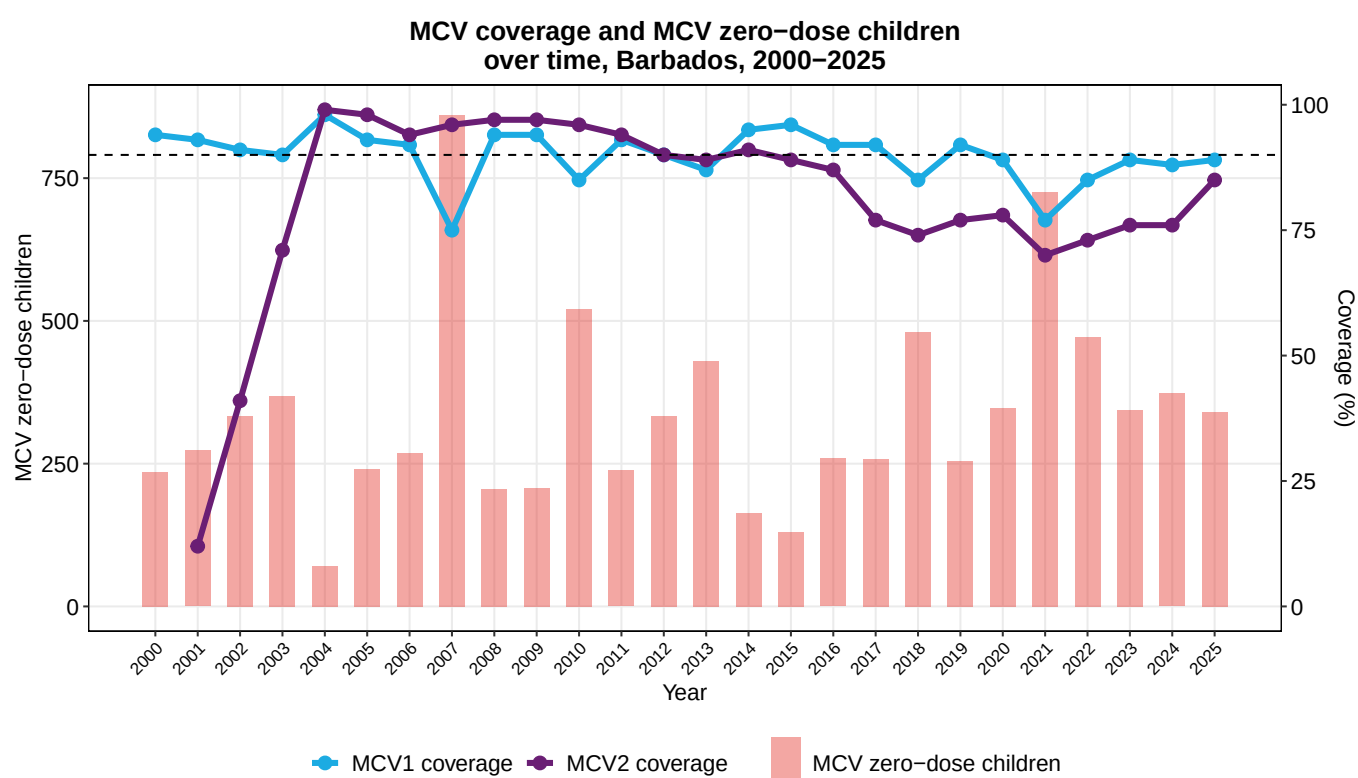
**DTP3 coverage and un- or under-vaccinated children over time, Barbados, 2000–2025**

## MCV: Canary in the coal mine

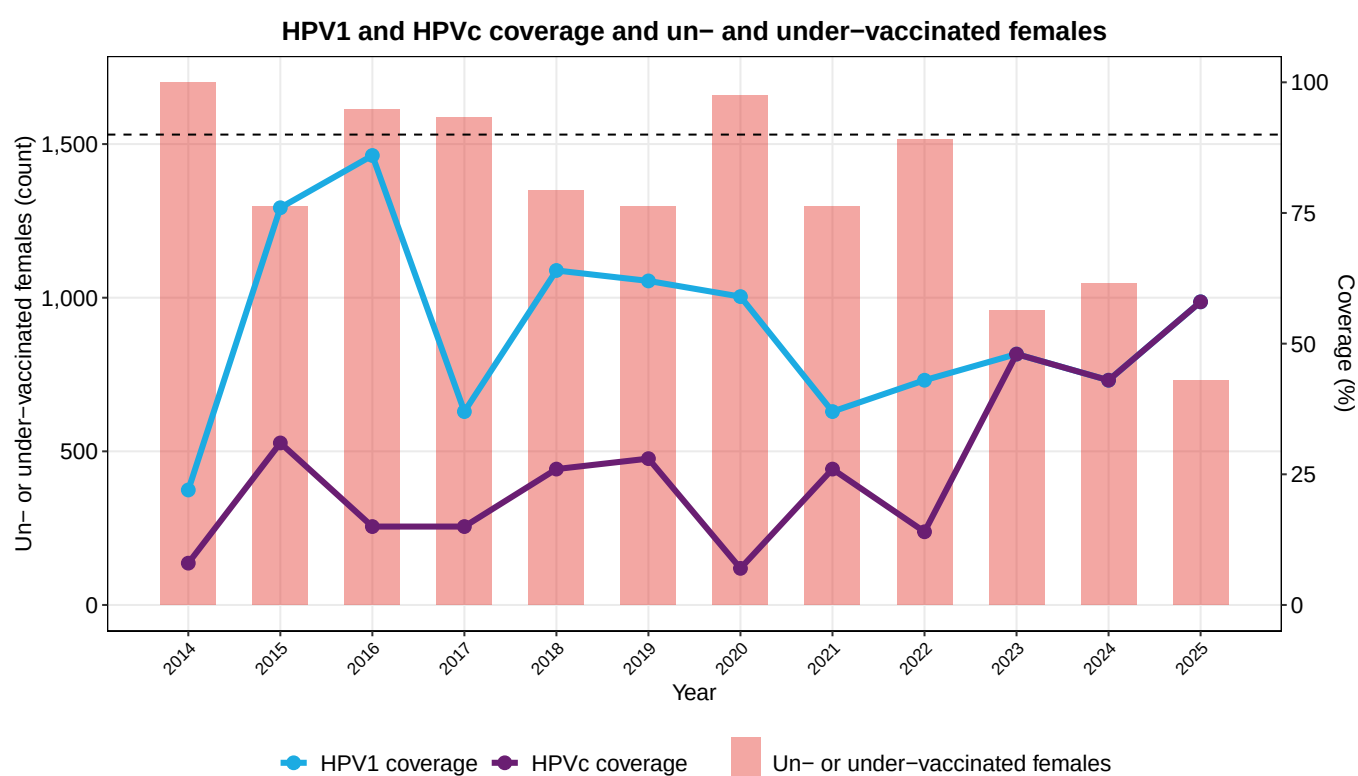
- Coverage of MCV1 stood at 89% in 2025. This is lower than in 2019 (92%) and higher than in 2024 (88%).
- Coverage of the second dose of the measles-containing vaccine (MCV2) increased from 77% in 2019 to 85% in 2025. This leaves <500 children without any protection against measles and another <200 with only partial protection.
- In 2025, 2% of children who received DTP1 did not receive MCV1. This 2% dropout rate was 2 percentage points higher than in 2019 (0%) but 4 percentage points lower than the 2024 dropout rate (6%).
- Barbados has achieved MCV1 coverage above 80% over all of the last 3 years.
- Coverage of MCV1 in Barbados (89%) was higher than the Latin America and the Caribbean regional average of 86% in 2025.

## HPV

- Programme coverage of HPV1 among females increased from 43% to 58% between 2024 and 2025, and coverage of the last dose (HPVc) also increased from 43% to 58%.
- HPVc coverage remains well below the IA2030 target of 90%, though it is trending upward.
- In 2025, approximately <1,000 females in Barbados did not receive any HPV vaccination (unvaccinated).
- Among Latin America and the Caribbean region peers, Barbados ranked 20 out of 31 countries in HPVc coverage in 2025.



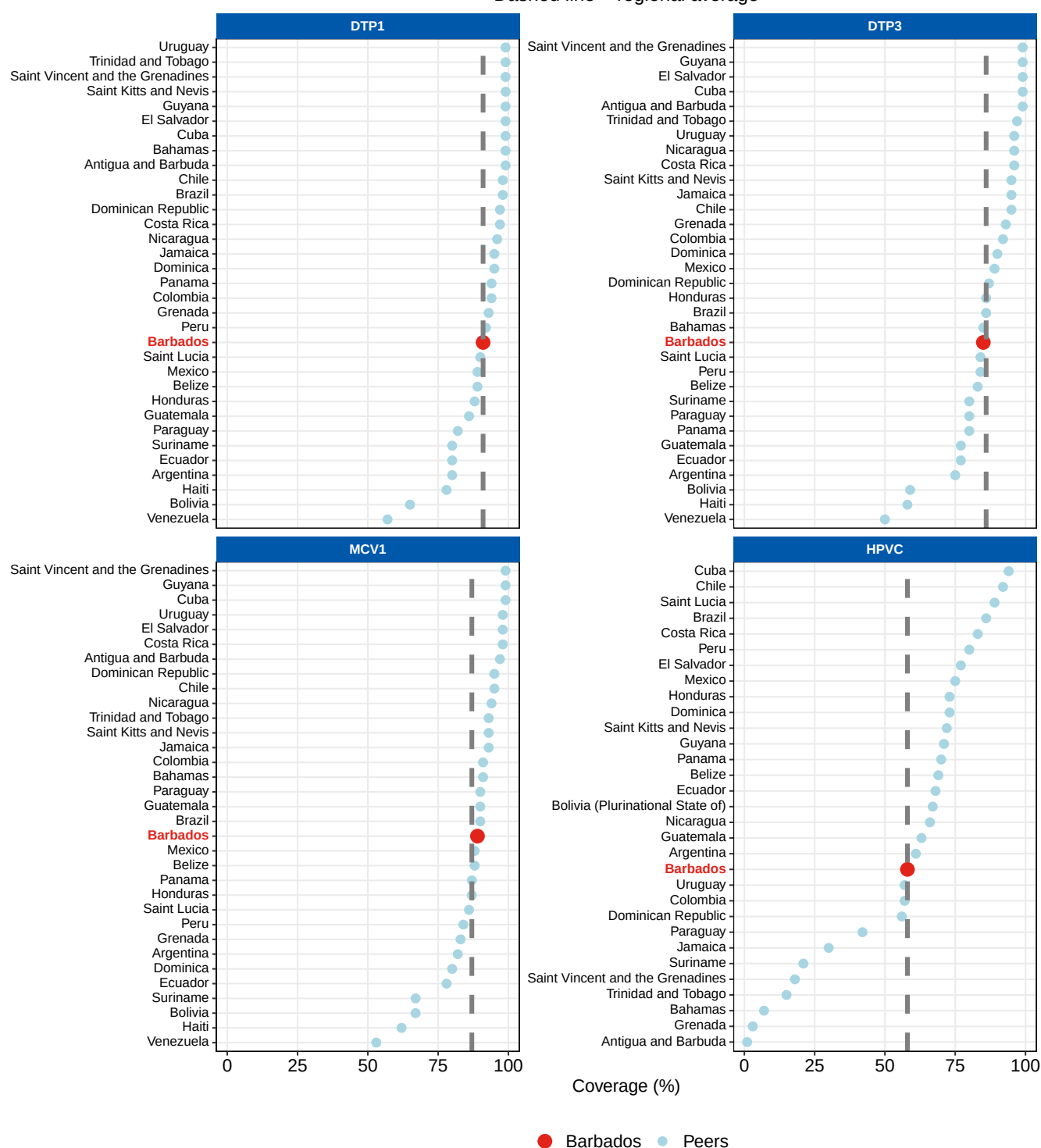

## Regional Comparison

The chart below shows how Barbados compares to other countries in the Latin America and the Caribbean region on DTP1, DTP3, MCV1, and HPVc coverage in 2025. The dashed line represents the regional average for each vaccine.

Dashed line = regional average

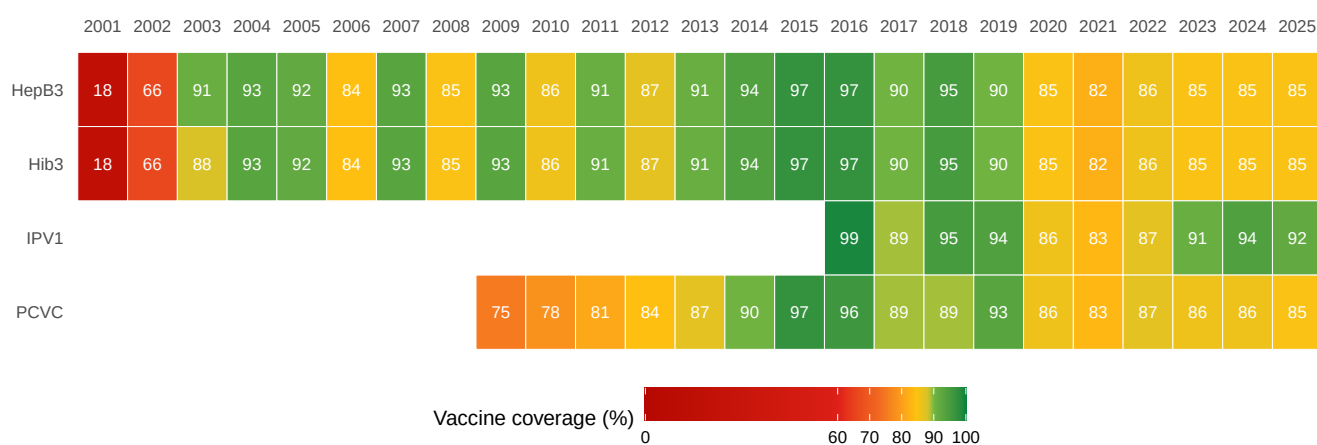

## Additional Vaccines

- Coverage of HepB3 stood at 85% in 2025. This is lower than in 2019 (90%) and the same as in 2024 (85%).
- Coverage of Hib3 stood at 85% in 2025. This is lower than in 2019 (90%) and the same as in 2024 (85%).
- Coverage of IPV1 stood at 92% in 2025. This is lower than in 2019 (94%) and lower than in 2024 (94%).
- Coverage of PCVC stood at 85% in 2025. This is lower than in 2019 (93%) and lower than in 2024 (86%).

## Appendix

### WHO/UNICEF Estimates of National Immunization Coverage (WUENIC)

Each year, WHO and UNICEF review national immunization data from Member States, including administrative and official coverage, survey estimates and contextual information, and use rules-based data triangulation approach to assess coverage. Estimates are produced independently, without borrowing data from other countries, and are not based on ad hoc adjustments. In some cases, they rely on a single source, typically nationally reported coverage. When data for a specific country-vaccine-year are unavailable, values from adjacent years are interpolated or extrapolated, and conflicting sources are assessed to determine the most reliable estimate, considering potential biases and expert opinion.

### Definitions of immunization terms:

- Bacillus Calmette-Guerin (BCG): vaccine against tuberculosis
- Hepatitis B birth dose, given within 24 hours after birth (HepBB)
- Diphtheria, tetanus, and pertussis vaccine, first dose (DTP1) and third dose (DTP3)
- Hepatitis B vaccine, third dose (HepB3)
- Haemophilus influenzae type B vaccine, third dose (Hib3)
- Inactivated polio vaccine, first dose (IPV1) and last dose (IPVC)
- Measles containing vaccine, first dose (MCV1) and second dose (MCV2)
- Rotavirus vaccine, last dose (RotaC)
- Pneumococcal vaccine, last dose (PCV)
- Yellow Fever vaccine (YFV)
- Meningococcal A vaccine (MengA)
- Human Papillomavirus vaccine, first dose (HPV1) and last dose (HPVc)
