

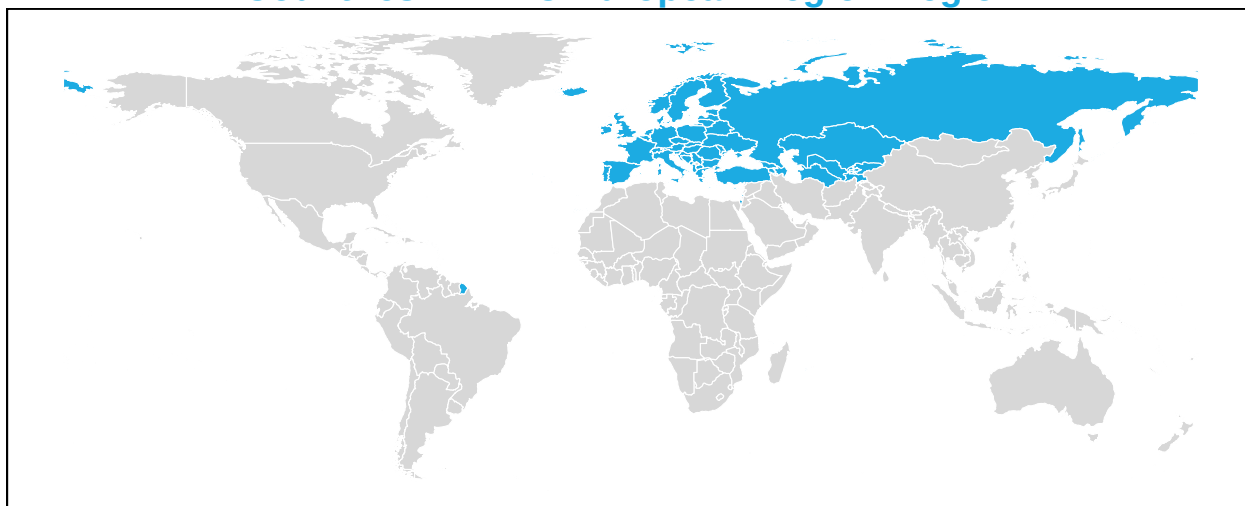

Countries in WHO European Region Region



- The WHO European Region region includes the following 53 countries: Albania, Andorra, Armenia, Austria, Azerbaijan, Belarus, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Czechia, Denmark, Estonia, Finland, France, Georgia, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Kazakhstan, Kyrgyzstan, Latvia, Lithuania, Luxembourg, Malta, Monaco, Montenegro, Netherlands (Kingdom of the), North Macedonia, Norway, Poland, Portugal, Republic of Moldova, Romania, Russian Federation, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Tajikistan, Turkiye, Turkmenistan, Ukraine, United Kingdom, and Uzbekistan.

Overview

- While noting variations across countries and vaccines, 7 out of the 13 childhood vaccines achieved an average coverage of 90% or higher within the WHO European Region region in 2025.
- Coverage of the first dose of diphtheria-tetanus-pertussis-containing vaccine (DTP1) was the same in 2025 as it was in 2024 (94%), and coverage of the third dose of DTP-containing vaccine (DTP3) was the same in 2025 as it was in 2024 (91%). Coverage of the first dose of the measles-containing vaccine (MCV1) was the same in 2025 as it was in 2024 (92%).
- A total of 49 out of 53 countries reached target coverage (90%) for all 13 antigens, representing 92% of the region.
- There were 4 countries that did not meet the target coverage across all antigens: Estonia, Kazakhstan, Romania, and San Marino.
- In 2025, the number of zero-dose children (566,000) was approximately 68% higher than the annual number proposed to achieve the Immunization Agenda 2030 target of reducing the number of zero-dose children by half by 2030 in WHO European Region region (336,000), based on a linear trajectory of decline.

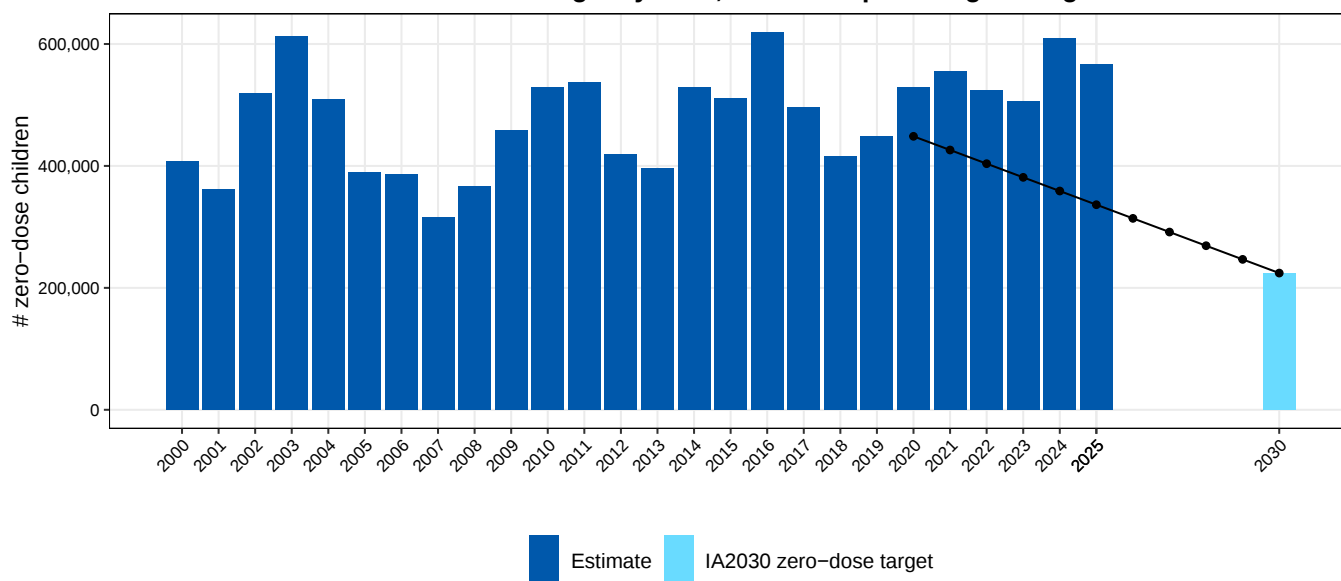

DTP1: Reaching zero-dose children

- The number of children vaccinated with DTP1 decreased 12.6% from 10.2 million in 2019 to 8.9 million in 2025.
- DTP1 coverage in 2025 was 94%, lower than in 2019 (96%) and the same as in 2024.
- In 2025, the number of zero-dose children (566,000) was approximately 68% higher than the annual number proposed to achieve the Immunization Agenda 2030 target in EUR region (336,000), based on a linear trajectory of decline.
- In 2025, Kazakhstan and Turkiye represented approximately 24% and 11% of all zero-dose children in EUR (n = 566,000), respectively. Kazakhstan had the highest number of zero-dose children at 134,000, and Turkiye had the second highest at 63,000.
- In 2025, the lowest DTP1 coverage was observed in Azerbaijan at 65%, followed by Kazakhstan at 66%.
- There were 44 (83%) out of 53 countries in the region that achieved DTP1 coverage of 90% or higher in 2025.

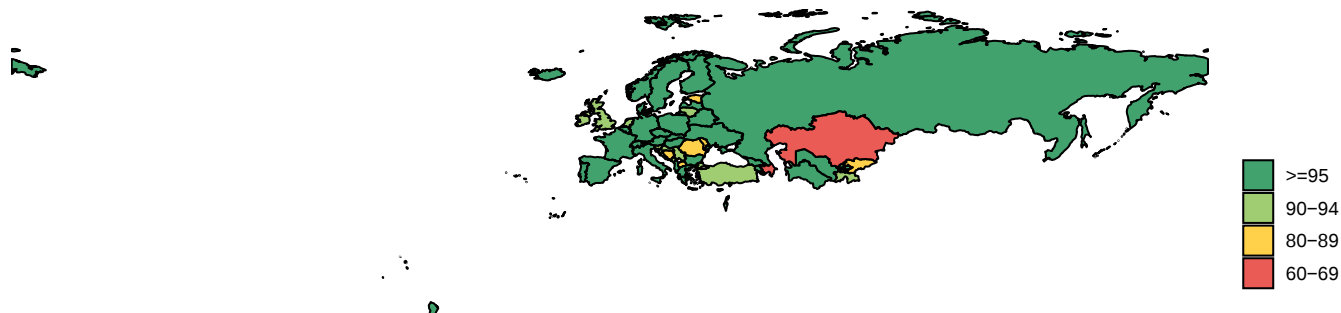

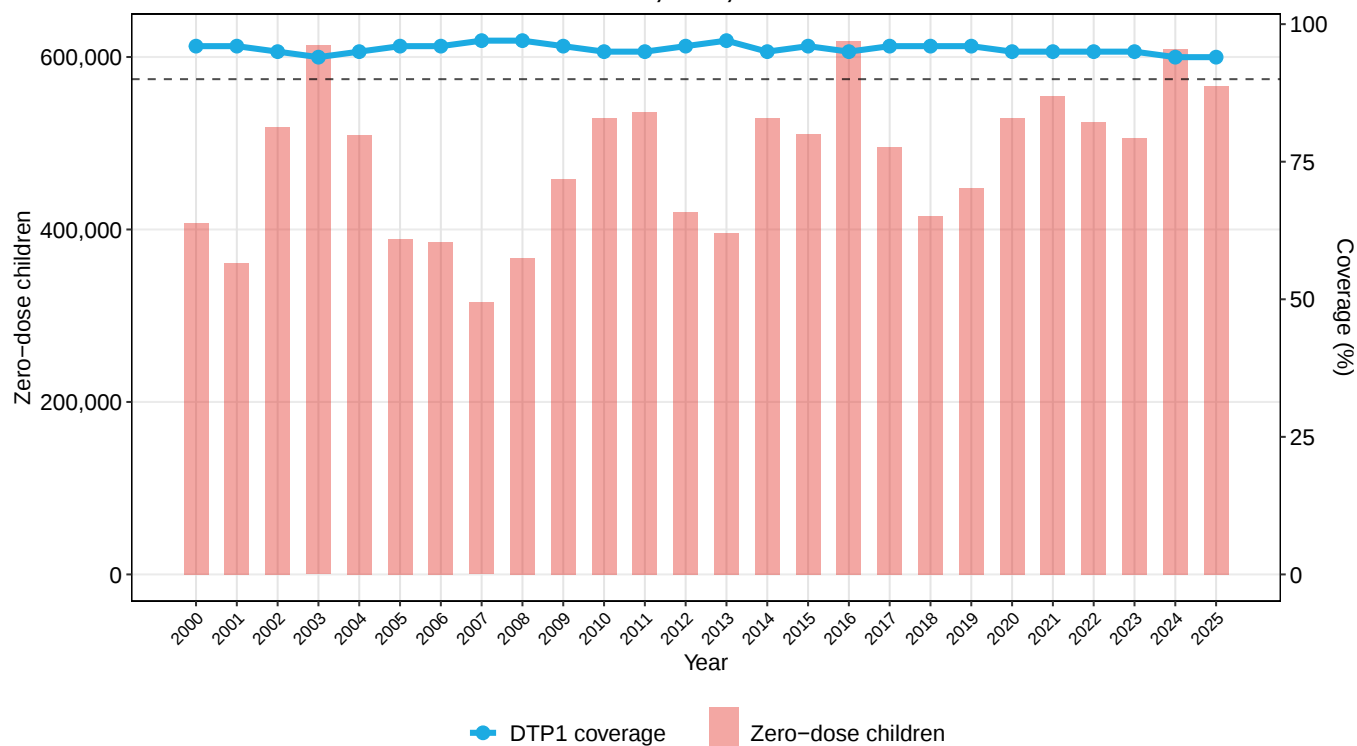

DTP3: A marker of routine immunization service delivery to children

- The number of children vaccinated with DTP3 decreased 13.2% from 9.9 million in 2019 to 8.6 million in 2025.
- DTP3 coverage in 2025 was 91%, lower than in 2019 (94%) and the same as in 2024.
- In 2025, 3% of children who received DTP1 did not receive DTP3, which was 1 percentage point higher than in 2019 (2%); low dropout rates imply good ability to provide a complete series of vaccines early in life.
- In 2025, DTP3 coverage ranged from 51% in Azerbaijan to 99% in Hungary, Latvia, Luxembourg, Malta, Monaco, and Portugal.
- In 2025, Kazakhstan had DTP3 coverage of 54% and the highest absolute number of un- and undervaccinated children in the region (181,000), followed by Germany with 89% coverage and 78,000 un- and undervaccinated children.

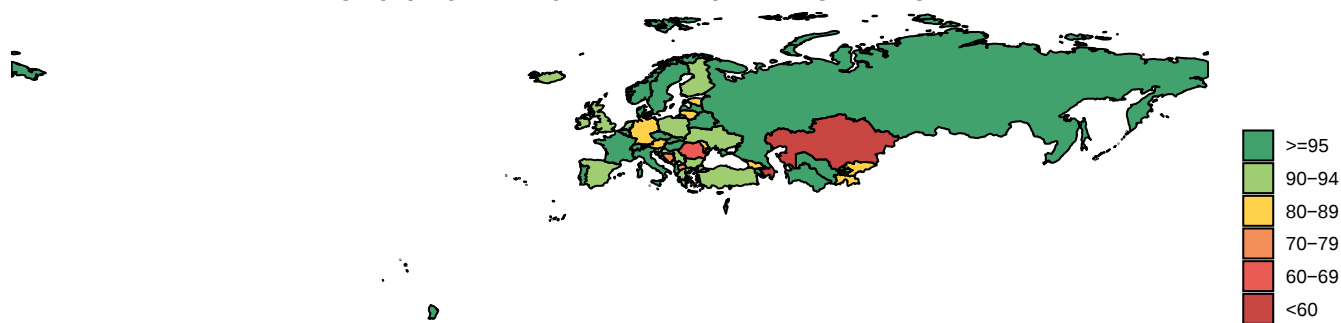

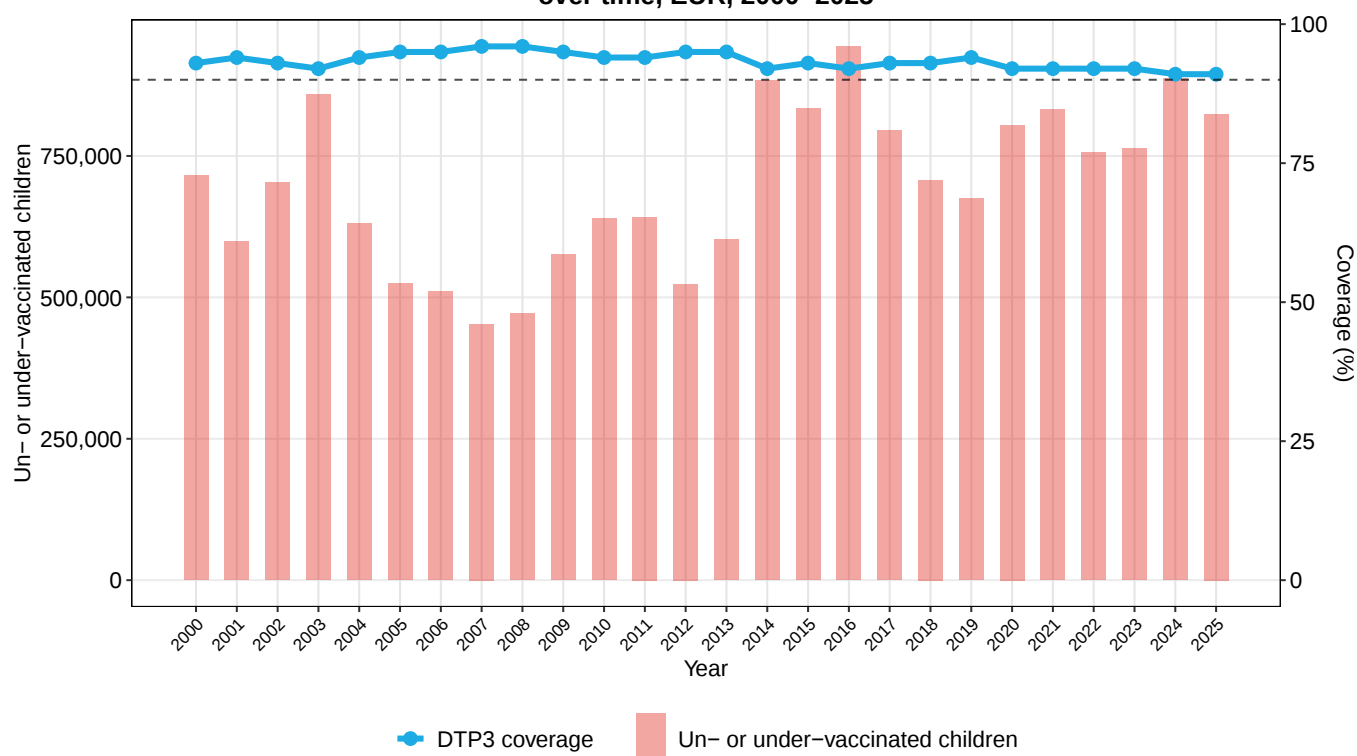

MCV: Canary in the coal mine

- MCV1 coverage in 2025 was 92%, lower than in 2019 (94%) and the same as in 2024.
- Coverage of the second dose of the measles-containing vaccine (MCV2) in 2025 was 89%, lower than in 2019 (91%) and the same as in 2024. This leaves 786,000 children without any protection and another 354,000 with only partial protection against the measles virus.
- In 2025, 2% of children who received DTP1 did not receive MCV1. This 2% dropout rate was the same as in 2019 (2%) and the same as the 2024 dropout rate (2%).
- Low DTP-MCV dropout rates imply good retention and ability to provide a full course of vaccines in infancy.
- 6 countries (Azerbaijan, Bosnia and Herzegovina, Kazakhstan, Montenegro, North Macedonia, and Romania) had MCV1 coverage below 80% for all of the last 3 years.
- In 2025, Kazakhstan had the highest number of children who did not receive the measles vaccine (137,000), representing approximately 17% of all children unprotected against measles in EUR (786,000).

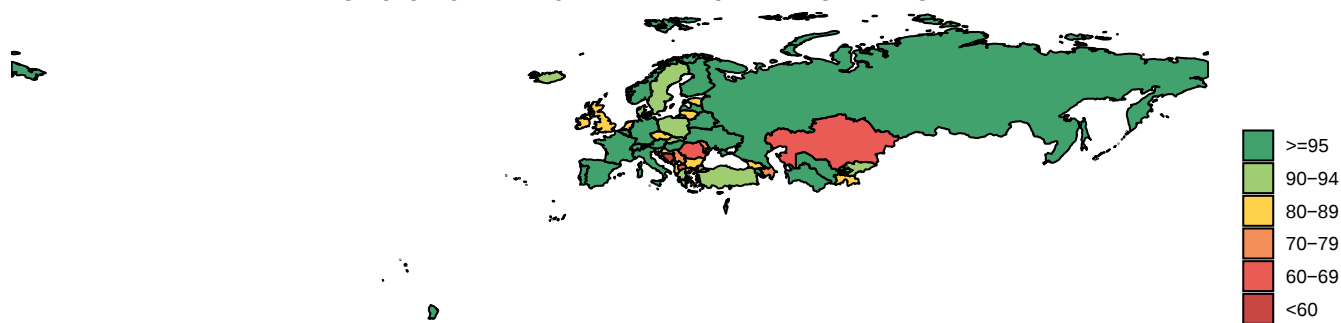

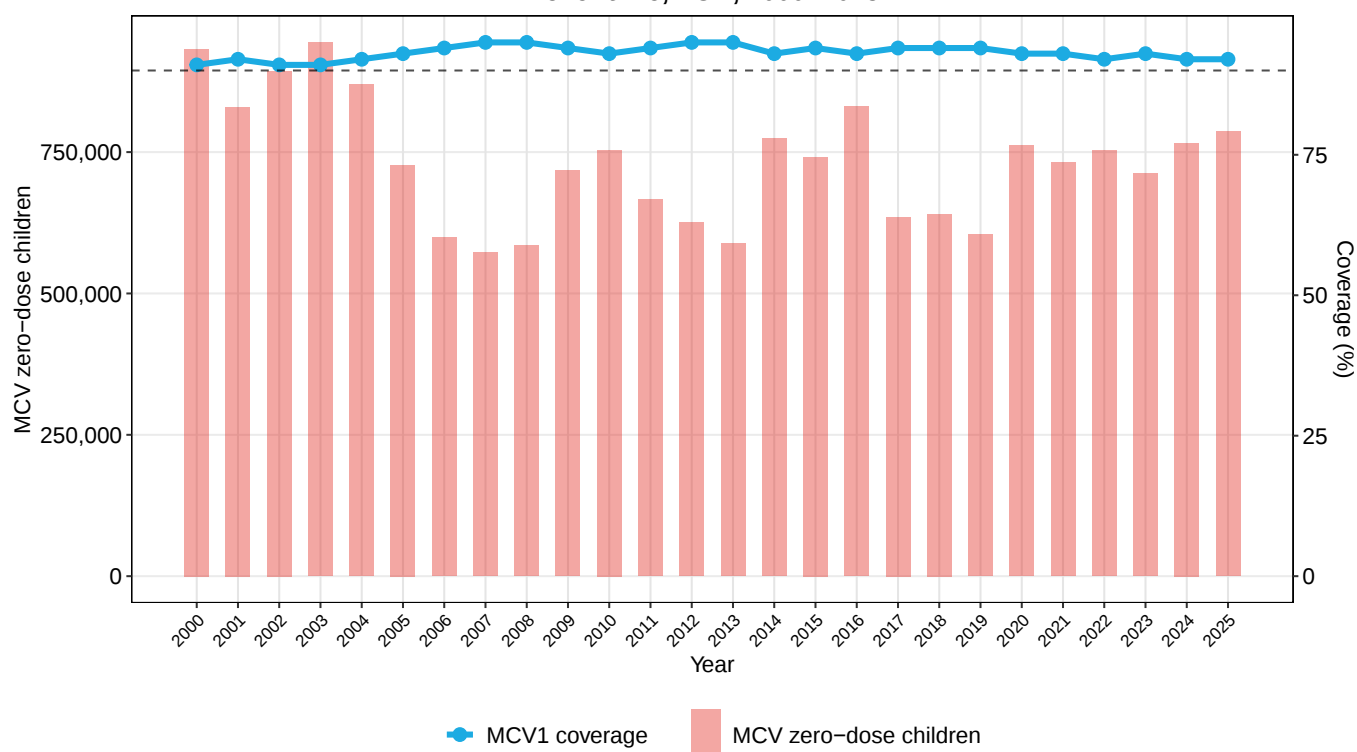

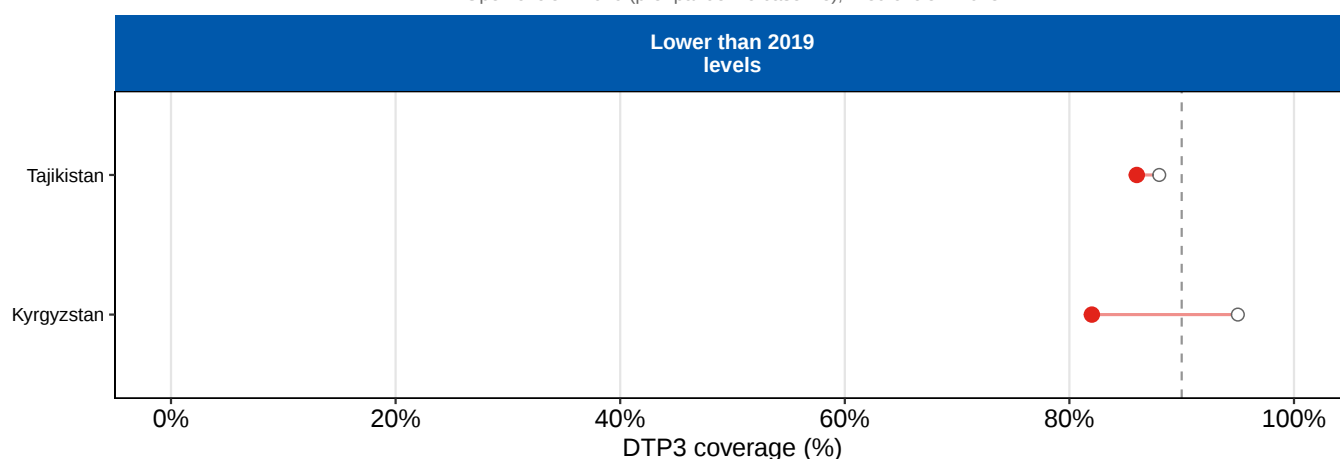

Recovery Methodology

This analysis tracks DTP3 coverage trends from 2019 to 2025 to assess post-pandemic recovery. Countries are categorized based on their progress toward 2019 baseline levels:

- **Recovered or strengthened:** 2025 coverage is equal to or higher than 2019 levels.
- **Partially recovered:** Coverage in 2025 is still below 2019 levels but has improved by at least 3 percentage points from its lowest point in 2020 or 2021.
- **Lower than 2019 levels:** Coverage in 2025 remains below 2019 levels and has shown less than 3 percentage points of improvement from its lowest point in 2020 or 2021.

Appendix

WHO/UNICEF Estimates of National Immunization Coverage (WUENIC)

Each year, WHO and UNICEF review national immunization data from Member States, including administrative and official coverage, survey estimates and contextual information, and use rules-based data triangulation approach to assess coverage. Estimates are produced independently, without borrowing data from other countries, and are not based on ad hoc adjustments. In some cases, they rely on a single source, typically nationally reported coverage. When data for a specific country-vaccine-year are unavailable, values from adjacent years are interpolated or extrapolated, and conflicting sources are assessed to determine the most reliable estimate, considering potential biases and expert opinion.
