

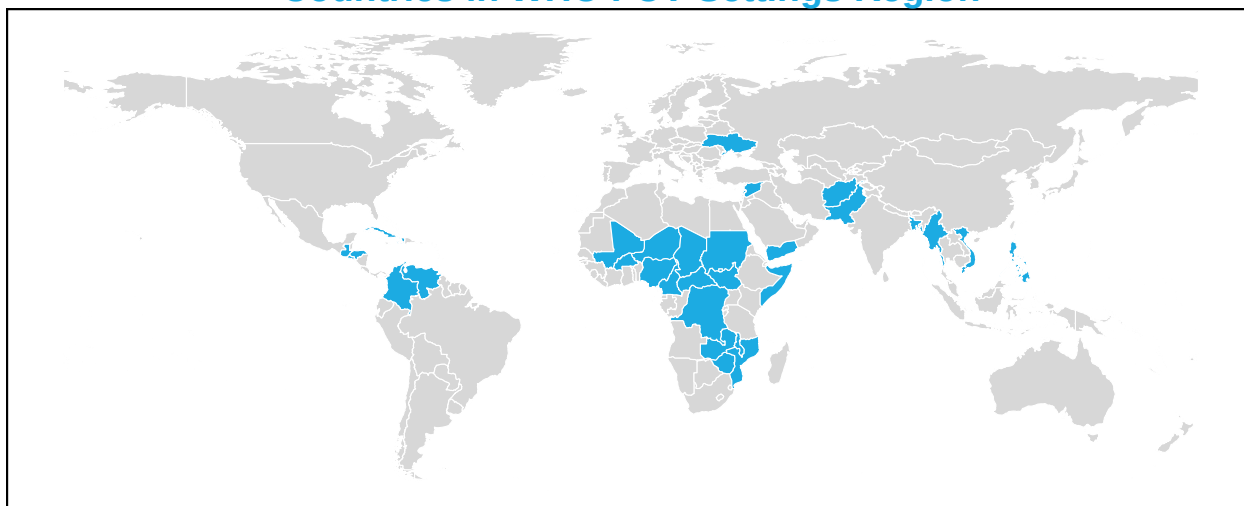

Countries in WHO FCV Settings Region



- The WHO Fragile, Conflict, and Vulnerable (FCV) Settings region includes the following 32 countries: Afghanistan, Bangladesh, Burkina Faso, Cameroon, Central African Republic, Chad, Colombia, Cuba, DRC, El Salvador, Guatemala, Haiti, Honduras, Lebanon, Malawi, Mali, Mozambique, Myanmar, Niger, Nigeria, Pakistan, Philippines, Somalia, South Sudan, Sudan, Syria, Ukraine, Venezuela, Viet Nam, Yemen, Zambia, and Zimbabwe.

Overview

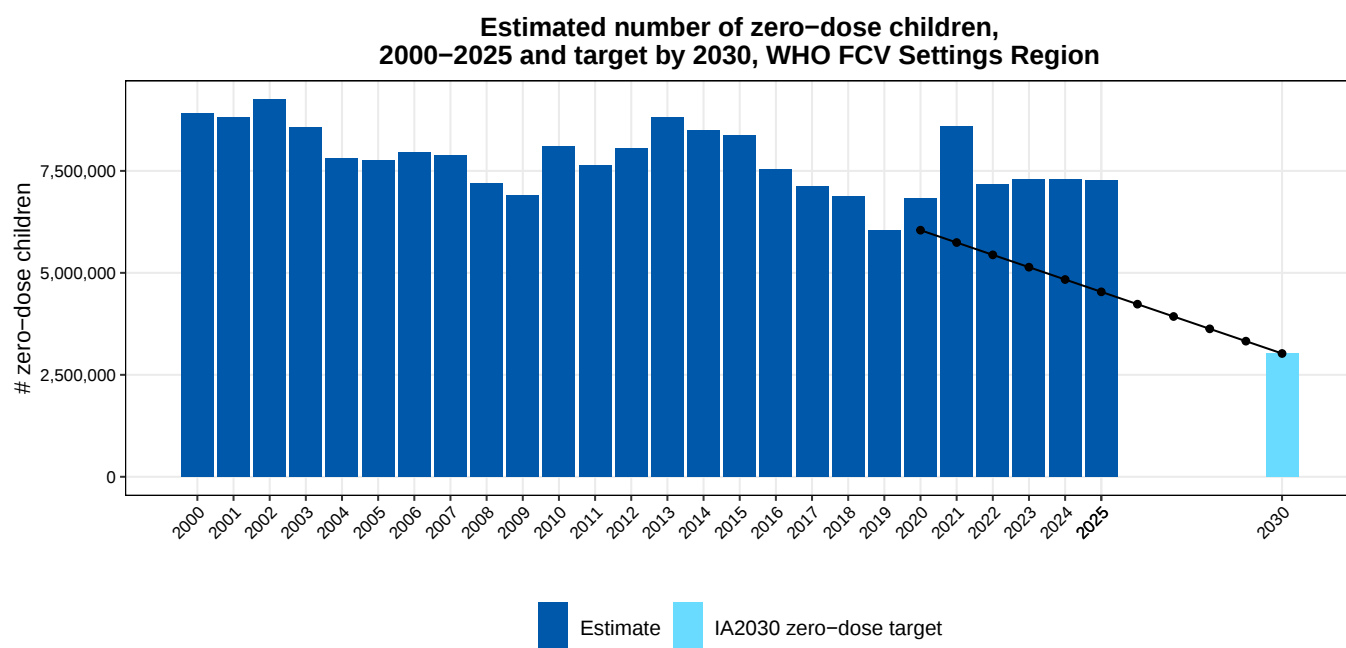
- While noting variations across countries and vaccines, none of the 15 childhood vaccines achieved an average coverage of 90% or higher within the WHO Fragile, Conflict, and Vulnerable (FCV) Settings region in 2025.
- Coverage of the first dose of diphtheria-tetanus-pertussis-containing vaccine (DTP1) was the same in 2025 as it was in 2024 (83%), and coverage of the third dose of DTP-containing vaccine (DTP3) increased from 74% in 2024 to 75% in 2025. Coverage of the first dose of the measles-containing vaccine (MCV1) declined from 72% in 2024 to 71% in 2025.
- A total of 17 out of 32 countries reached target coverage (90%) for all 15 antigens, representing 53% of the region.
- There were 15 countries that did not meet the target coverage across all antigens: Afghanistan, Central African Republic, DRC, Haiti, Honduras, Lebanon, Myanmar, Nigeria, Philippines, Somalia, South Sudan, Sudan, Syria, Venezuela, and Yemen.
- In 2025, the number of zero-dose children (7.3 million) was approximately 60% higher than the annual number proposed to achieve the Immunization Agenda 2030 target of reducing the number of zero-dose children by half by 2030 in WHO Fragile, Conflict, and Vulnerable (FCV) Settings region (4.5 million), based on a linear trajectory of decline.

The line and points show the yearly progress and trajectory to meet the target by 2030, based on a linear decline.

DTP1: Reaching zero-dose children

- The number of children vaccinated with DTP1 increased 3.1% from 34 million in 2019 to 35 million in 2025.
- DTP1 coverage in 2025 was 83%, lower than in 2019 (85%) and the same as in 2024.
- In 2025, the number of zero-dose children (7.3 million) was approximately 60% higher than the annual number proposed to achieve the Immunization Agenda 2030 target in WHO FCV region (4.5 million), based on a linear trajectory of decline.
- In 2025, Nigeria and DRC represented approximately 30% and 11% of all zero-dose children in WHO FCV (n = 7.3 million), respectively. Nigeria had the highest number of zero-dose children at 2.2 million, and DRC had the second highest at 788,000.
- In 2025, the lowest DTP1 coverage was observed in Yemen at 49%, followed by Venezuela at 57%.
- There were 14 (44%) out of 32 countries in the region that achieved DTP1 coverage of 90% or higher in 2025.

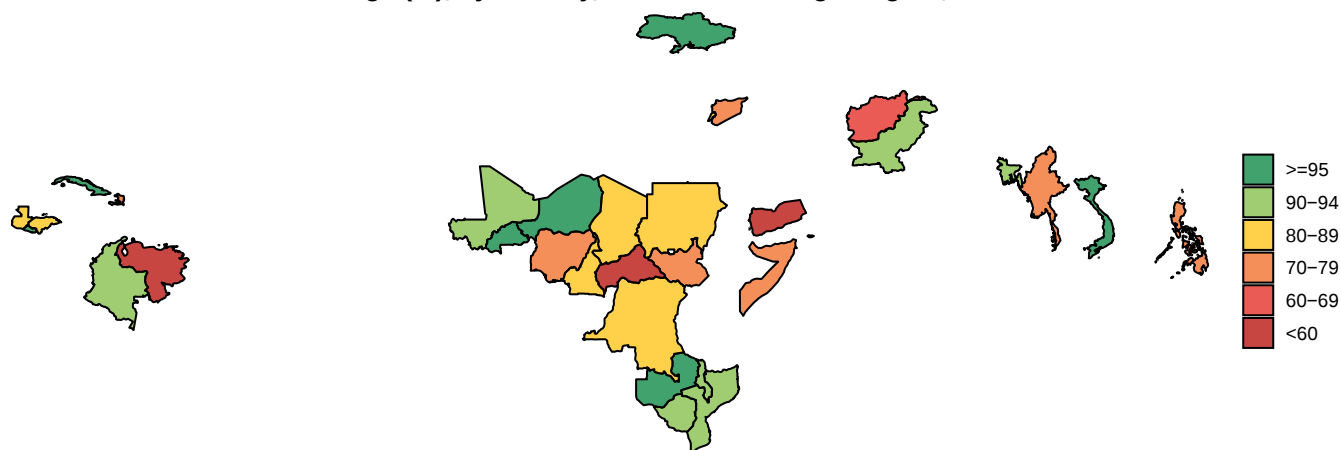

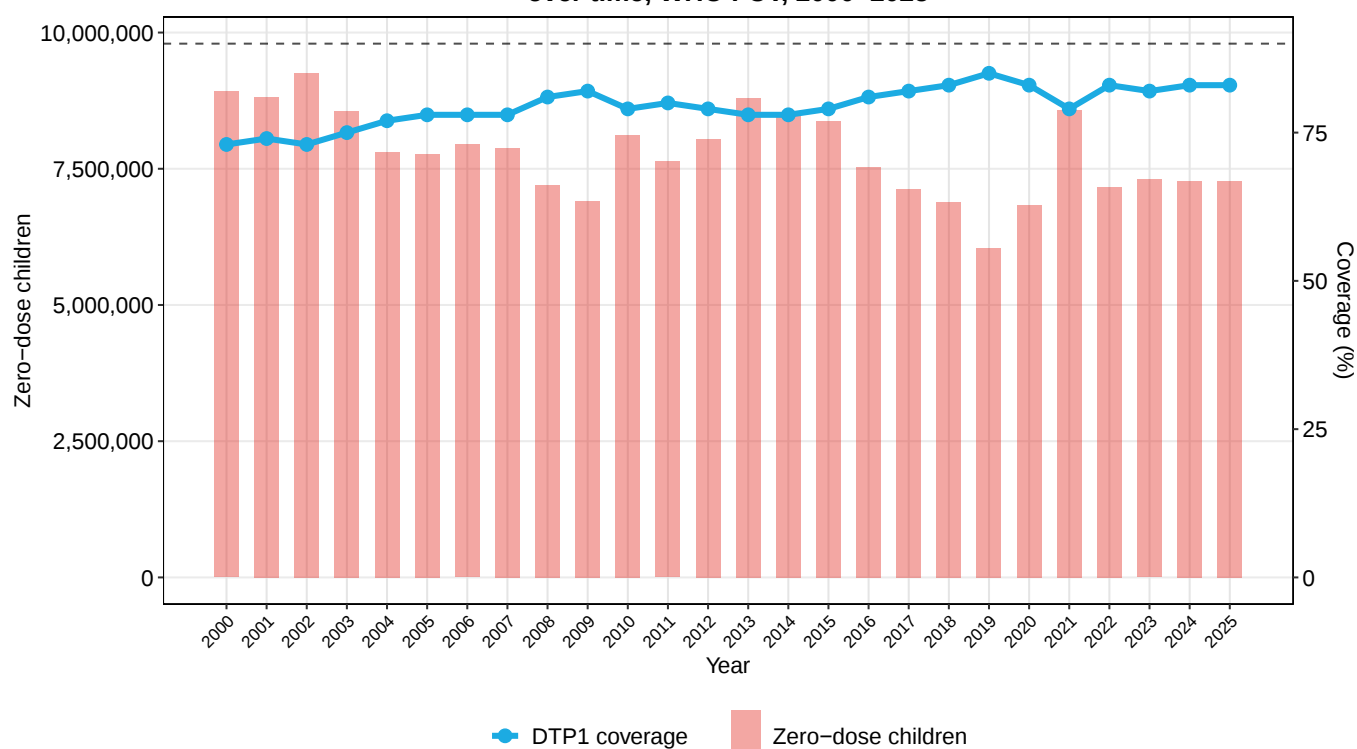

DTP3: A marker of routine immunization service delivery to children

- The number of children vaccinated with DTP3 increased 0.5% from 31.4 million in 2019 to 31.6 million in 2025. Due to population growth of approximately 6% between 2019 and 2025, DTP3 coverage in 2025 (75%) was lower than in 2019 (78%).
- DTP3 coverage in 2025 was 75%, lower than in 2019 (78%) but higher than in 2024 (74%).
- In 2025, 10% of children who received DTP1 did not receive DTP3, which was 2 percentage points higher than in 2019 (8%); medium dropout rates imply moderate ability to provide a complete series of vaccines early in life.
- In 2025, DTP3 coverage ranged from 39% in Yemen to 99% in Cuba and El Salvador.
- In 2025, Nigeria had DTP3 coverage of 62% and the highest absolute number of un- and undervaccinated children in the region (2.8 million), followed by DRC with 65% coverage and 1.5 million un- and undervaccinated children.

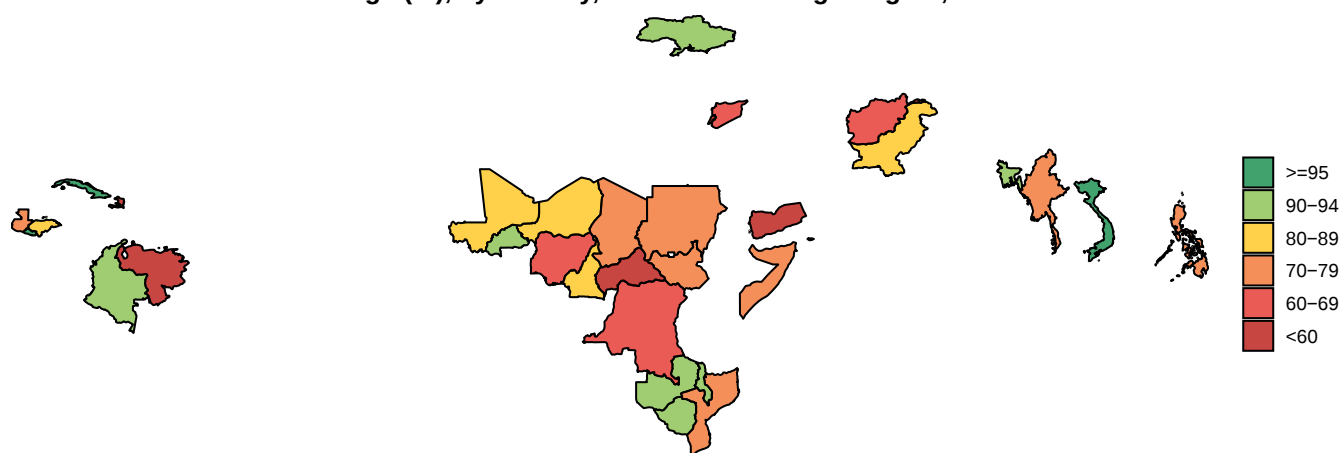

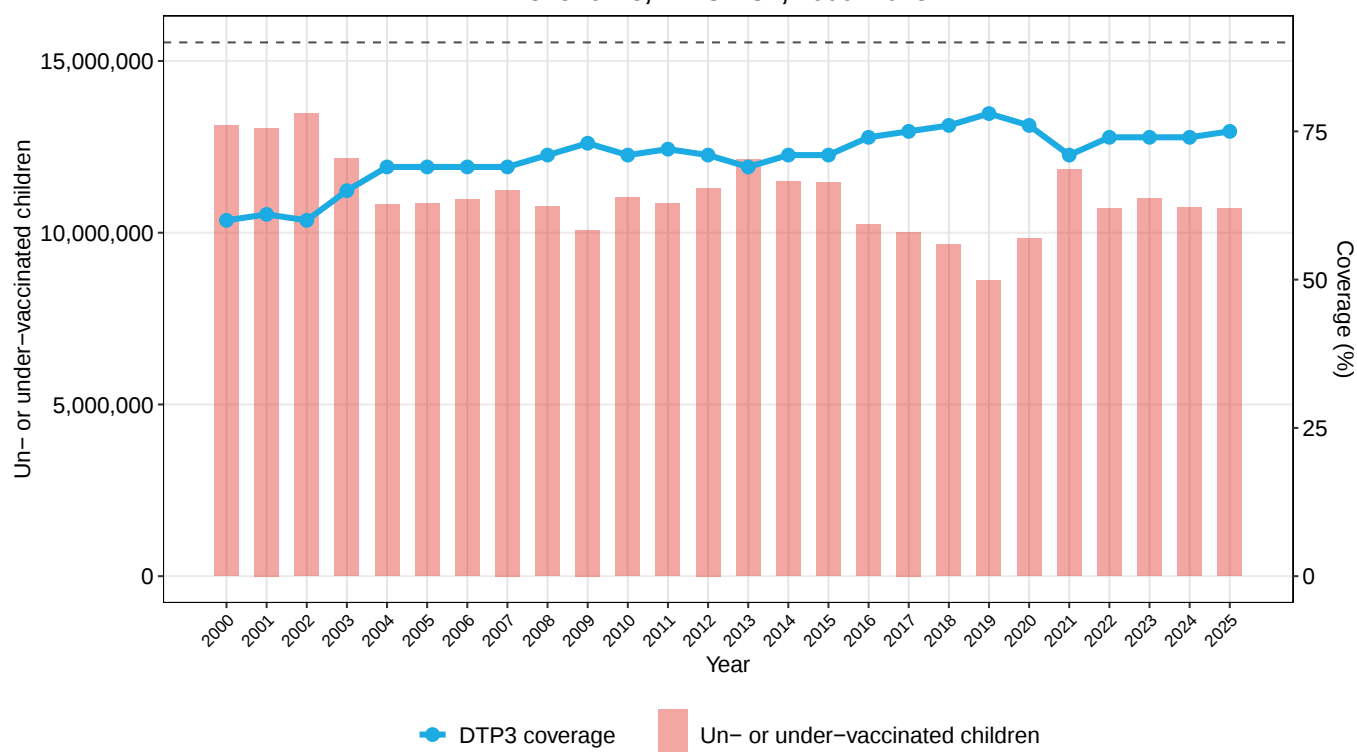

MCV: Canary in the coal mine

- MCV1 coverage in 2025 was 71%, lower than in 2019 (75%) and the same as in 2024.
- Coverage of the second dose of the measles-containing vaccine (MCV2) in 2025 was 61%, higher than in 2019 (49%) and the same as in 2024. This still leaves 12.2 million children without any protection and another 3.5 million with only partial protection against the measles virus.
- In 2025, 14% of children who received DTP1 did not receive MCV1. This 14% dropout rate was 3 percentage points higher than in 2019 (11%) and higher than the 2024 dropout rate (13%).
- High DTP-MCV dropout rates imply poor retention in immunization programmes.
- 16 countries (Afghanistan, Cameroon, Central African Republic, Chad, DRC, Haiti, Lebanon, Mali, Mozambique, Myanmar, Nigeria, Somalia, South Sudan, Sudan, Venezuela, and Yemen) had MCV1 coverage below 80% for all of the last 3 years.
- In 2025, Nigeria had the highest number of children who did not receive the measles vaccine (3.2 million), representing approximately 26% of all children unprotected against measles in WHO FCV (12.2 million).

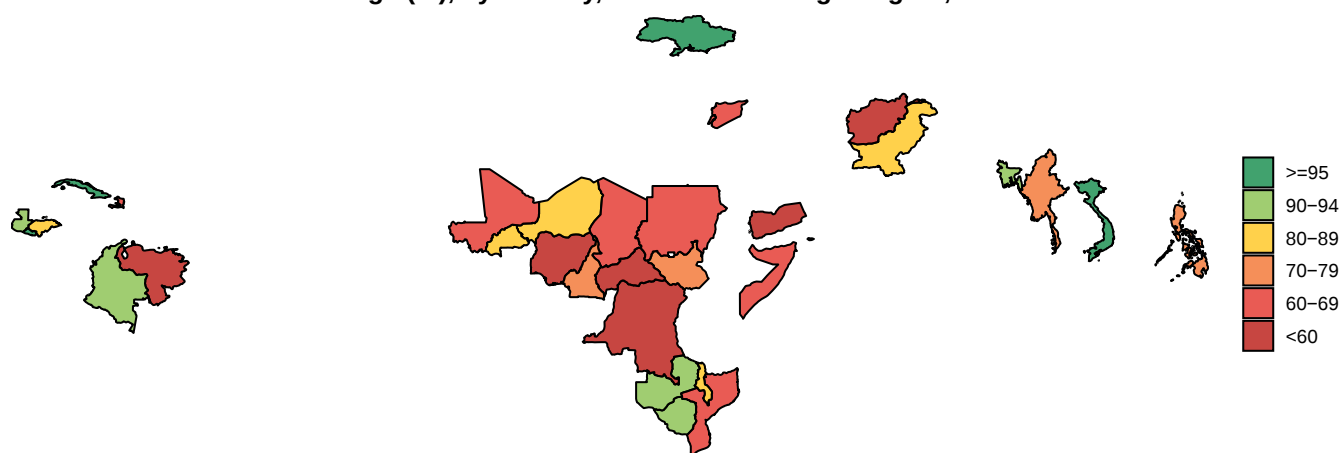

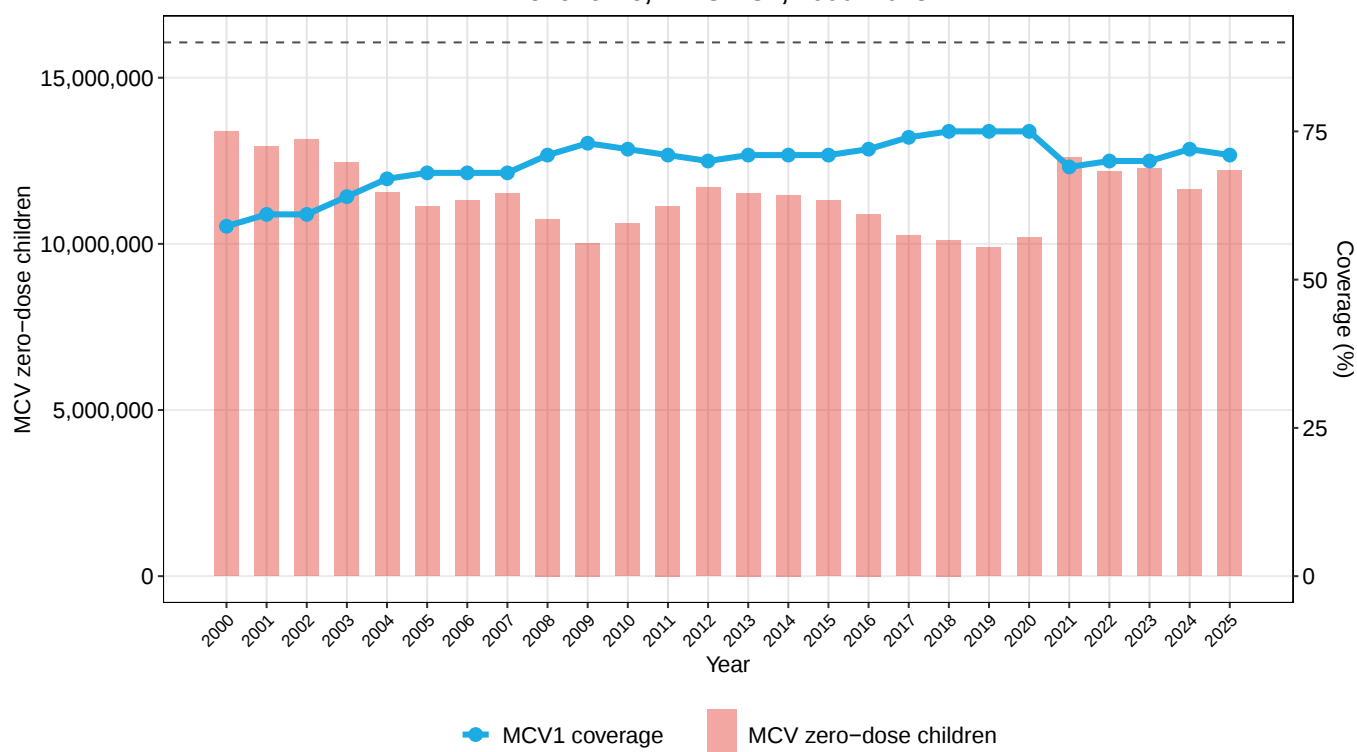

MCV coverage and MCV zero-dose children over time, WHO FCV, 2000-2025

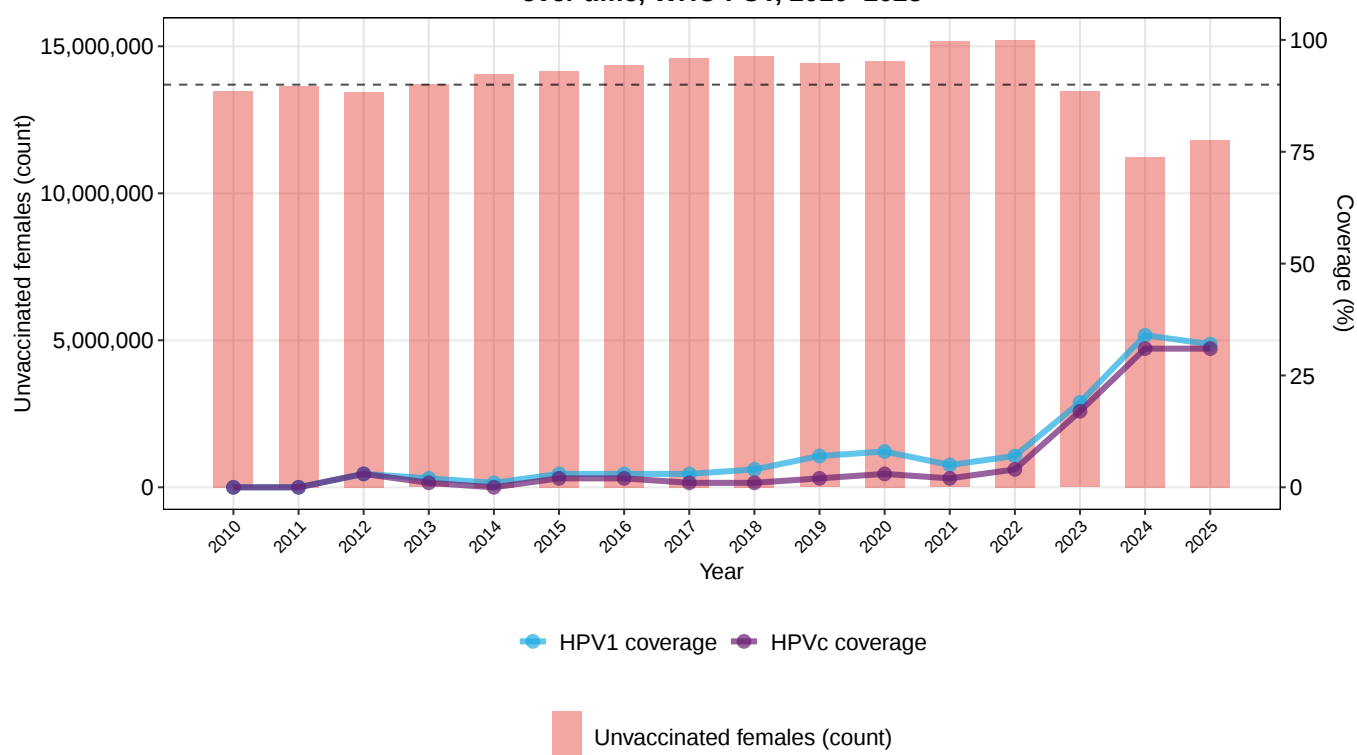

HPV

- Programme coverage of the first dose of HPV vaccine (HPV1) among girls stood at 32% in 2025, which was lower than the coverage of 34% in 2024.
- Coverage of the last dose (HPVc) stood at 31% in 2025, which was the same as the coverage in 2024.
- HPVc coverage remains well below the IA2030 target of 90%.
- In 2025, there were 11.8 million girls who did not receive any HPV vaccination.
- In WHO FCV, 17 out of 32 countries (53%) had introduced HPV vaccination by 2025.
 - WUENIC HPV coverage estimates are available for all 17 of these countries in 2025.
- The 15 countries that had not introduced HPV vaccination are Afghanistan, Central African Republic, Chad, DRC, Haiti, Lebanon, Niger, Somalia, South Sudan, Sudan, Syria, Ukraine, Venezuela, Viet Nam, and Yemen.

HPV1 and HPVc coverage and unvaccinated females over time, WHO FCV, 2010–2025



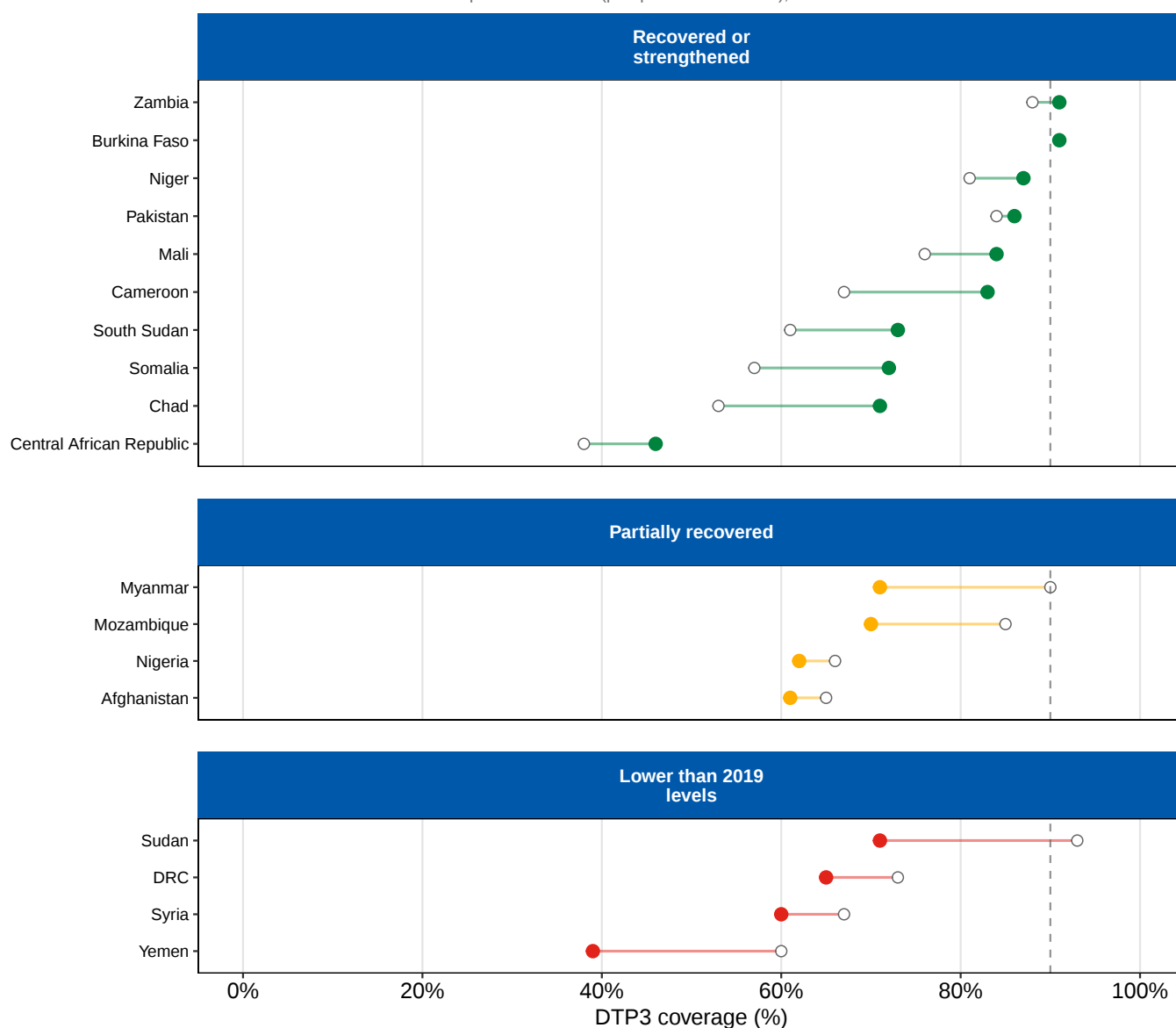

Priority countries supported to recover from the COVID-19 pandemic

- Of the 35 countries that were globally supported for the Big Catch-up, 18 are in WHO FCV.
 - Burkina Faso, Central African Republic, Cameroon, Mali, Niger, Pakistan, Somalia, South Sudan, Chad, and Zambia fully recovered to or exceeded their 2019 DTP3 levels.
 - 4 countries (Afghanistan, Myanmar, Mozambique, and Nigeria) are on the path to recovery to 2019 DTP3 levels.
 - 4 countries (DRC, Sudan, Syria, and Yemen) have not yet recovered, with stagnation or decline from 2019 DTP3 levels.
 - 5 countries (Burkina Faso, Cameroon, Niger, South Sudan, and Chad) did not experience a decline in DTP3 levels compared to 2019.

Recovery Methodology

This analysis tracks DTP3 coverage trends from 2019 to 2025 to assess post-pandemic recovery. Countries are categorized based on their progress toward 2019 baseline levels:

- **Recovered or strengthened:** 2025 coverage is equal to or higher than 2019 levels.
- **Partially recovered:** Coverage in 2025 is still below 2019 levels but has improved by at least 3 percentage points from its lowest point in 2020 or 2021.
- **Lower than 2019 levels:** Coverage in 2025 remains below 2019 levels and has shown less than 3 percentage points of improvement from its lowest point in 2020 or 2021.

Appendix

WHO/UNICEF Estimates of National Immunization Coverage (WUENIC)

Each year, WHO and UNICEF review national immunization data from Member States, including administrative and official coverage, survey estimates and contextual information, and use rules-based data triangulation approach to assess coverage. Estimates are produced independently, without borrowing data from other countries, and are not based on ad hoc adjustments. In some cases, they rely on a single source, typically nationally reported coverage. When data for a specific country-vaccine-year are unavailable, values from adjacent years are interpolated or extrapolated, and conflicting sources are assessed to determine the most reliable estimate, considering potential biases and expert opinion.

- Haemophilus influenzae type B vaccine, third dose (Hib3)
- Inactivated polio vaccine, first dose (IPV1) and last dose (IPVC)
- Measles containing vaccine, first dose (MCV1) and second dose (MCV2)
- Rotavirus vaccine, last dose (RotaC)
- Pneumococcal vaccine, last dose (PCV)
- Yellow Fever vaccine (YFV)
- Meningococcal A vaccine (MengA)
- Human Papillomavirus vaccine, first dose (HPV1) and last dose (HPVc)
