

Progress for Every Child in the SDG Era Country Profile



This Country Profile is based on an assessment of 44 indicators concerning children in the 2030 agenda. These indicators are grouped into five broad dimensions of child rights that cut across the Sustainable Development Goals. The five dials below illustrate the country's status in each dimension, based on an assessment of indicator performance against global targets. Each dial reveals what proportion of country indicators have met the global target, are on track to meet the target by 2030, require acceleration to reach the global target by 2030, or have no data, or insufficient data to plot trends. A more detailed breakdown for each indicator is provided overleaf. Data quality varies across countries, as indicated by the National Statistical Capacity score and the source year for indicators.
